Call for tender for the design and implementation of a Bayesian Hierarchical numerical Model (BHM) to produce realistic distribution of winds over the Mediterranean Sea.

The activities are included within the TESSA project (Development of Technologies for the "Situational Sea Awareness"). This tender is announced in accordance with Legislative Decree 163/2006, art. 125, paragraphs 9-11, combined with CMCC Procedures - REG01 ACQ01R3_Procedures for direct management of purchases.

CMCC Scarl Euro-Mediterranean Center for Climate Change publishes the public notice in order to express its interest to grant by fiduciary piecework "the design and implementation of a Bayesian Hierarchical numerical Model (BHM) to produce realistic distribution of winds over the Mediterranean Sea.

The activities are included within the TESSA project (Development of technologies for the Situational Sea Awareness)".

The notice aims at acquiring the expression of interest to select suitable economic operators who will be invited later to make a bid for "the design and implementation of a Bayesian Hierarchical numerical Model (BHM) to produce realistic distribution of winds over the Mediterranean Sea.

The amount available for the supply is approximately of € 80,000.00 Euros, in addition to VAT and any other charge pursuant to the law.

The expression of interest to participate in the above-mentioned selection must be sent by email no later than **Tuesday 5th August 2014 at h 1 p.m.** and must be drawn up according to Annex A., with attached request for expression of interest and the declaration of qualification.

3. those submitted by economic operators whose position or function is inconsistent with the law or the procedure, or whose eligibility is excluded from the conditions envisaged by this notice;

4. those submitted by economic operators who are subject to one of the causes of exclusion referred to article 38 of Legislative Decree 163/2006 and subsequent amendments and additions, and which is ascertained in any moment and by any means;
5. those submitted by economic operators subject to any other cause of exclusion from participation in tenders for the provision of public supplies/services or from negotiation with the public administration, pursuant to the applicable legislation on the subject of public procurement contracts, ascertained in any moment and by any means.
